- 1. That the draft Resourcing Plan, incorporating the Workforce Plan, Asset Management Strategy and Long Term Financial Plan be considered and adopted.
- 2. That in adopting the Long Term Financial Plan Scenario "business as usual", consideration should be given to financial requirements for funding the upgrading of Council's assets in future financial models.
- 3. That in adopting the Asset Management Strategy, Council also adopts the Asset Management Plans for:
 - Transport and Storm Water
 - Water Supply and Sewerage
 - Buildings
 - Other Assets.
- 4. That the draft plant and vehicle replacement program be considered and adopted for inclusion in the 2012/13 Operational Plan and Budget.
- 5. That the draft Delivery Program 2012-2016 be considered and approved for public exhibition.
- 6. That the 'dogs' fees and charges on page 36 of the Revenue Policy contained in the draft Operational Plan and Budget 2012/13 be amended for 'second and subsequent impounding within 3 months' from \$100 to \$200.
- 7. That the draft Operational Plan and Budget 2012/13 be considered and approved for public exhibition. (Hampstead/Dutton)
